

**Saint Lucie County Republican Executive Committee**  
**Minutes of the Executive Board**  
**March 10, 2022**

The meeting was called to order at 6:00 pm. Chairman Nail led the all-in attendance in the pledge of allegiance.

Attending from the Executive Board: Kenny Nail, Chad Miller, Butch Post, Kim Dabe allowing for a quorum. Anthony Bonna attended via Zoom and Mary Ann Russell was absent.

The Executive Board met in a joint meeting with the Steering Committee. This is the anticipated format for the foreseeable future. The meeting will be regularly scheduled the Thursday prior to the monthly scheduled REC on the third Thursday. The meetings will start at 6:00PM.

D. Kim Dabe, Chair of Finance discussed Audit activities, The Audit will be completed in a few days and submitted to the SOE. Other activities included; merchandising and inventory purchases planned. The scheduled purchases are in the approved budget.

E. Vickie Wolf, chair of events offered comments regarding this weekend's gun show, Food Festival, Food Truck events, Red Folder distribution and Campaign Sidekick training.

F. June Lamson, announced a planned event: Freedomworks/Best Candidate Training which will occur on April 9<sup>th</sup>. June noted that the a interested parties, REC members, parents activities at the School Board meetings is getting noticed.
