

SAINT LUCIE COUNTY REPUBLICAN EXECUTIVE COMMITTEE MEETING MINUTES FOR April 19, 2022

1. The meeting was called to order with a quorum (39) (51 present) at 6:10 PM.
2. The Pledge of Allegiance was led by Margret McConnell.
3. Pastor Sam Chess opened with the invocation
4. Chairman's message:
 - A. Chairman Nail asked for the REC members to raise their hands. He then spoke briefly about the role of the REC members as elected officials.
 - B. We are currently working on election integrity and monitoring the redistricting taking place in our County. Gayle Harrel will have about 20% of the county with the balance going to candidate Erin Grall.
 - C. Kenny introduced Joey Katz, the new regional director for the RPOF and reintroduced Maddox Stirrat, deputy director RPOF. Maddox reminded all that this weekend would be a day of action with canvassing activities. Training on Campaign Sidekick would be on Friday at 6pm at the REC office. We were reminded of the current match of Rep and Dem registered in Saint Lucie County. We are now down 8,943 to the Dems.
 - D. We will pay special attention to the school board races and we continue to look for more qualified candidates for these races.
5. Consent Agenda: Chairman Nail ask for a motion to approve the Consent Agenda, Motion by Ana Gomez-Malanda and seconded by Butch Post, motion passed.
6. Chairman Nail had a resolution included in the consent agenda read by Vickie Wolf and then asked for a motion to approve this resolution and forward it to Saint Lucie County School Board. See Attached
7. Butch Post welcomed all visitors and asked each to say a few words.
8. Vickie Wolf spoke about some of the campaign activities including this weekends Day Of Action with Campaign Sidekick walk books and canvasing. We need to work on helping candidates get petitions signed. Freedom Fest with Senator Rubio and Congressman Mast is getting close.....
9. Vice Chair Chad Miller did a brief presentation on a number of topics including:

 - Fact Number 1: The Primary Election is Happening on August 23rd
 - Fact Number 2: We are getting out the vote for Republican Candidates and Incumbents
 - Fact Number 3: The Treasure Coast Freedom Night Dinner with Marco Rubio is April 29.

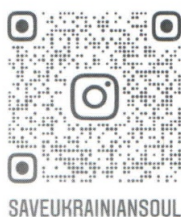


How will the funds be used?

**A Resolution of the
St Lucie County Republican Executive Committee**

Calling on the School District of St Lucie County, Florida to ensure policy is aligned with Florida State Statutes for all curriculum to include instructional and supplemental materials for students, teachers and/or teacher training and development.

WHEREAS, the 10th Amendment of the Constitution of the United States of America, ratified effective December 15, 1791, decrees that "The powers not delegated to the United States by Constitution, nor prohibited by it to the States, are reserved by the States respectively, or to the people." Therefore, declaring that education is a states' rights issue, and

WHEREAS, the Florida Constitution states, "*Article 1. Section 1. Public Education.* - (a) The education of children is a fundamental value of the people of the State of Florida." and "Adequate provision shall be made by law for a uniform, efficient, safe, secure, and high-quality system of free public schools that allows students to obtain a high quality education..." and

WHEREAS, under Florida Statutes, *Title XLVI. Chapter 847 Obscenity*, the School Board is accountable to and responsible for ensuring children do not have access to obscene, lewd, and/or harmful materials within the public education facilities, and

WHEREAS, under Florida Statutes, *Title XLVIII. Chapter 1006.28 through 1006.42 Instructional Materials for K-12 Public Education*, designates the School Board accountable and responsible for ensuring instructional materials have a review process prior to student access, and

WHEREAS, under Florida Statutes, *Title XLVIII. Chapter 1006.283 District school board instructional material review process (1)* states "A district school board or consortium of school districts may implement an instructional materials program that includes the review, recommendation, adoption and purchase of instructional materials." and

WHEREAS, under Florida Statutes, *Title XLVIII. Chapter 1006.283 District school board instructional materials materials review process (2)(a)* states "If a District School Board chooses to implement its own instructional materials program, the school board shall adopt rules implementing the district's instructional materials program which must include its processes, criteria and requirements for the following:..." and

WHEREAS, parents, grandparents, citizens and taxpayers in the community are opposed to elected officials allocating public monies for instructional materials which are age inappropriate, offensive, lewd or otherwise do not provide edification or advancement to student learning and which do not align with state statutes, and

WHEREAS, instructional materials include any and all curriculum, books, media, online resources or other learning tools used in the classrooms, libraries, media centers or in public facilities or property: therefore be it

RESOLVED that the St. Lucie County Republican Executive Committee calls the School District of St. Lucie County to make changes to policies which ensure that students are provided with instructional materials that align consistently with Florida State Statutes designed to protect children.
