- 1. Chairmans Comments: Kenny is working on budget for the 2022 campaign. We need to get our candidates in front of voters. To do so we will need 15,000 door hangers and at least two mail drops. The first on July 21st to corresponds with Vote By Mail ballots sent from SOE. Second mailing will probably be just before early voting. We will focus on early voting and VBM voters having a low interest in midterm elections. These voters may be called Gov-by-no-shows because they historically do not vote in election years for governor. Kenny expects the budget to be \$20,000.
- 2. Chairman Nail appointed and Ad Hoc committee to design door hangers and other campaign literature. K. Nail, C. Miller, B. Mucklow.
- 3. Kenny introduced an new candidate for School Board, Donnita Graben. (See attached) Donnita is very qualified and meets the standards for the position. She will be introduced to the REC at the meeting on May 17th.
- 4. Treasurer Report. Kim Dabe filled in for Russ Ansley who is out of town. The April bank statement had an opening balance of \$25,737 and a closing balance of \$53,487. This increase is due to the efforts of Butch Post and her team raising sponsors and advertisers for the Treasure Coast Freedom Night (Rubio dinner).
- 5. the Treasure Coast Freedom Night: Butch post gave a summary of the event and thanked her team. Final cost and income are not in but she anticipates that we should see \$25K net.
- 6. Murchandise: Judy Glass described what was going on in the office and event merchandising. She made her case to spend up to \$3,500 through June. This was put to a motion where by the executive board will recommend to the REC to approve this expenditure. Motion by Kenny Nail, seconded by Butch Post, motion carried.

- 7. Voter integrity: Barry Mucklow, chair of VI now has 35 members of his committee. They meet regularly and will have a real presence at the next election.
- 8. Events: Vicky Wolf reported on this committee activities. Multiple training sessions are scheduled and are listed on the website calendar. Canvassing is up and running almost every weekend.
- 9. Good of the order: Tea party next meeting on April 5th.
- 10. Members moved to Draft House and had last comments and vote.
- 11. Meeting adjourned at 7:45.
