

# Minutes of the Republican Executive Committee Meeting February 21st, 2023 As submitted by Sherri Propis, SLC REC Secretary

Meeting called to order by Chairman Kenny Nail at 6:06 pm

Pledge of Allegiance led by Anthony Bonna's daughter Opening Prayer led by Pastor Massey Campo

- 1. Chairman Nail's Message:
  - a. Chairman Nail asked for prayers of healing for MaryAnn Russell and Amy Decker
  - b. Chairman Nail will be on vacation in March. Vice-Chair Chad Miller will lead the March REC meeting
  - c. Chairman Nail highlighted the Voter Registration results last 30 days:
    - i. Republicans gained 161 registrations
    - ii. As of the meeting, Republicans are only 4779 registrations behind the Democrats
  - d. There are 2 social issues coming from the RNC
    - i. 2<sup>nd</sup> Amendment Committee:
      - 1. Richard Stein agreed to chair this committee
      - 2. Committee will inform the SLC GOP on issues/legislation regarding the 2<sup>nd</sup> Amendment
      - 3. Committee will organize phone banks, etc. to get the word out to voters
      - 4. Goal is to get SLC to process concealed carry permits so residents don't have to go out of county to get their permit
        - a. Gabby Rothman, candidate for SLC Tax Collector will get this process in SLC if elected. Current Tax Collector, Chris Craft is up for re-election
    - ii. Sanctuary County for the Unborn:
      - 1. SLC GOP is working behind the scenes to get a bill passed to be a Sanctuary County for the Unborn
      - 2. This is a spiritual war driving this issue
      - 3. Must stand with the commission when this issue comes up; must get the word out when it happens so we can stand with them—crowd of support 25<sup>th</sup> & Virginia Ave
  - e. Voter Integrity Committee
    - i. Kenny Nail will lead
    - ii. REC's are the grassroots for this issue

    - i. Larry went to DC with a delegation and met with our representatives: issue that arose is the need for corrective language in legislation to fix the loss of individual healthcare if arrested in SLC—taxpayers foot that bill. This was unknown to our representatives
  - c. Gabrielle Rothman: candidate for SLC Tax Collector: campaign kick-off March 8<sup>th</sup> 5-7 pm at TC Lexus
  - d. Joe James: candidate for SLC Property Appraiser
