- 1. Opening Comments from Chairman Kenny Nail
 - a. Chairman Nail welcomed the REC to its new venue: Synergy Magnet K-12 school
 - i. Thanks to Vice-Chair Chad Miller & Tim Fuller for arranging the new digs!

 - a. Congratulations to all our candidates! Your hard work and dedication are appreciated!
 - b. Thanks also to all the volunteers working polls, information tents and canvassing
 - c. Primary Recap:
 - i. Registered voters: 235,734: Ballots cast: 48,481 20.57% voter turnout
 - 1. 27k Republican votes
 - 2. 16K Democrat votes
 - d. It will be VITAL to get an additional 14-15k more Republican voters more than Democrats in the general to beat incumbent SOE Gertrude Walker
 - i. Because she has been in office 44 years, she will get Republican and NPA votes; we MUST turn out the vote!

- ii. Barry Mucklow has been monitoring the SOE office for years and there are questionable practices/occurrences that we need to correct
 - 1. Ex: 900 sq foot home in Fort Pierce had 52 registered Democrats at that address
- e. In that same vein, incumbent Tax Collector, Chris Craft has been in office a long time and has name recognition. We MUST turn out the EDUCATED AGAINST CHRIS CRAFT Republican vote!

9. Candidates Speeches

- a. Dana Trabulsy: gave thanks for the support, reminded us we need to come together to fight to win; we need to be strategic in our voter turnout: % of women, % of ethnicities & % of Democrats will be key especially given the incumbent make-up and Amendment 4 on the ballot
- b. Chairman Nail iterated last election cycle we had 12-28 field officers dispatched to our area to help the voter turnout in 2020— this cycle we have 0; the \$ is going to what is considered battleground states—it will be up to US to get out the vote!
- c. SOE candidate Jennifer Frey—thanks for the help of the volunteers; we need to unite to win! SOE incumbent Gertrude Walker MUST be defeated—during the recount there was a ballot box OUTSIDE the secure cage, a violation; the volunteers watching polls, ballot box drop-offs and counts MUST have knowledge of the process and what to look for
 - i. We must get US immigration to share citizen/immigrant status to the SOE's to ensure non-citizens are not voting!
- d. Tax Collector candidate Gabby Rothman: gave multiple reasons why Chris Craft must be removed from office, including horrific customer service, reduced hours/days for service, not offering a multitude of revenue-producing services other counties offer
- e. School Board incumbent Jennifer Richardson: thank you for the win and volunteer support
- f. State Committeewoman (elected) Laura Roscoe: this is everyone's victory; it is the American dream for a legal immigrant to achieve office; we must fight illegal immigration and open borders; Laura promises to give her all to this position to represent us at the state level
- g. County Commissioner Cathy Townsend was not available due to SLC BOCC meeting
- h. County Commissioner Erin Lowry was not available: took some time off with family after the election

- a. Red Elephant Award: Joe James for tirelessly knocking doors, registering voters and educating voters
- b. Vice-Chair Chad Miller stated the new door hangers and flyers will be available for viewing on Friday or Saturday
